



# GENERAL TERMS OF REGISTRATION

## AFRICA ECO RACE – 16<sup>TH</sup> EDITION

By simply registering, the competitor and all members of the crew to which they are attached (competitor-assistance-raid-press) agree to comply with the following terms of registration.

### RALLY DATES

- ✓ December 27 and 28: Technical and administrative checks
- ✓ December 28: Start from Monaco
- ✓ January 12: Arrival at Lac Rose, Senegal

### INCLUDED IN THE REGISTRATION

- ✓ Official Start
- ✓ One-way boat transport to Morocco for each person in an interior cabin shared with three other people, including two nights on board
- ✓ Meals on the boat (self-service)
- ✓ Round-trip boat transport of the vehicle between Europe/ Morocco & Dakar/ France
- ✓ Customs formalities
- ✓ Bivouacs in Africa
- ✓ Meals at bivouacs (breakfast, packed lunch, dinner) and lunch at Lac Rose
- ✓ Award ceremony at Lac Rose
- ✓ ACERBIS rally T-shirt
- ✓ Royalty-free photo and video gallery
- ✓ Visa for Mauritania
- ✓ Vehicle insurance in Mauritania and Senegal
- ✓ Medical assistance, osteopaths
- ✓ Organizer's civil liability insurance
- ✓ Repatriation assistance (only for crews engaged on the race)

### GENERAL CONDITIONS

This contract, which includes the terms of registration, is governed by **Monegasque** law. Any disputes will be brought before the **Monaco Court**, unless amicably resolved. The technical organizer retains exclusive rights to filming, animated images, and sound recordings of AFRICA ECO RACE. "AFRICA ECO RACE" and "AFRICA RACE" are registered trademarks with the EUIPO. The sporting event organization (R.C.I 89 S 02530), designated as the technical organizer by the sporting associations (Asa Désert Aventures and Moto Club du Désert) holding the federal authorizations to organize the race according to current regulations. In case of a change in the technical organizer, this contract will continue with the newly designated organizer without any alteration. If the race is cancelled for any reason, the organizers' liability is limited to the reimbursement of any advances paid by the competitor. If a competitor cancels his participation for any reason, any amounts paid to the organizers will be retained by them.

To be processed, the registration request must be accompanied by the pre-registration fee according to the corresponding payment schedule. Registration will only be confirmed upon receipt of the full registration fee and a **€1 500** deposit. The registration must include an uploaded identity photo, a copy of the passport, driver's license, vehicle registration, and insurance. The registrant declares that all information provided in the mandatory online registration is accurate, and any inaccuracy may result in refusal to start. The registrant acknowledges that they are solely responsible for the validity of the various administrative documents required to participate in the **16th edition** of AFRICA ECO RACE in Europe, Morocco, Mauritania, and Senegal. The registrant declares they are fully aware of the risks involved during the event and absolves the organizers of AFRICA ECO RACE of any criminal or civil liability in the event of bodily or material accidents during the **16th edition of AFRICA ECO RACE**.

## REGISTRATION CONDITIONS

Only registrations accompanied by the initial payment will be considered.

Any participant wishing to register is subject to :

- ✓ The Specific Regulations of AFRICA ECO RACE
- ✓ The rules of the international sporting code

Registration Deadline : **November 1, 2024**

- ✓ The AFRICA ECO RACE organizer is the sole judge of limiting the number of competitors registered in each category and reserves the right to refuse to validate a competitor's registration.
- ✓ All services related to the registration and/or offered as options are **exclusively reserved and managed by O.S.E or by a service provider approved by O.S.E.**
- ✓ Only **O.S.E** is authorized to sell access to AFRICA ECO RACE.

## ADHERENCE TO PAYMENT DEADLINES

Any failure to comply with this rule will result in moving to the higher rate plus a 10% penalty. The Organizer reserves the right to not validate registrations that have not been paid in full by **November 1, 2024**.

The final names of the crews must be confirmed before **November 1, 2024**.

## PENALTIES AFTER NOVEMBER 1, 2024 IN CASE OF

- **Name or vehicle change:** Any change occurring after the registration deadline will incur a **€300 fee per change**.
- **Missing administrative document(s):** Any missing administrative document after the registration deadline will incur a **€300 penalty per document**.

## CANCELLATION CONDITIONS

For any cancellation of the registration request, deposits paid will be refunded as follows:

- **If cancelled before September 15, 2024 = 10% of the amounts paid will be retained for motorcycles/quads and cars/trucks.**
- **If cancelled on or after November 1, 2024 = 50% of the amounts paid will be retained and 50% will be transferred to the next edition.**

In cases of serious medical problems, the **Organizer** will consider a partial refund upon request (registered letter with acknowledgment of receipt) with a complete original medical file. **10% of the amounts paid will be retained.** Following administrative and technical checks, any crew refused at the start for non-compliance with administrative or technical requirements will not be entitled to any refund of registration fees.

## POSTPONEMENT

In the event of a delay/postponement of the Rally, the Organizer will officially inform of the new schedule. The Organizer will automatically transfer registrations to the new dates. These registrations do not guarantee the competitor's effective participation in the postponed edition, which remains subject to usual rules. In all cases, participants will not be entitled to any compensation. Deposits paid may be applied to the next edition.

## CANCELLATION OF THE EVENT

If the Rally cannot start for any reason, including but not limited to: non-obtainment and/or withdrawal of federal approvals, passage permits, political unrest in any of the countries crossed making the Rally impossible or dangerous from the Organizer's perspective, financial failure jeopardizing the technical and sporting organization of the Rally, boarding or disembarking problems, pandemic, etc. The Organizer would only be liable to competitors for the amounts received. The amounts received by the Organizer will be refunded no later than March 1, 2025 or transferred to the next edition, at the competitor's choice.

## METHOD OF PAYMENT

Payments must be made **EXCLUSIVELY** by bank transfer.

Bank details are provided on the invoice.

To avoid any confusion, you must include on your transfer order the team number and file number from the online registration, the name of your team, and the names of the vehicle drivers.

## **DEPOSIT**

For each registered vehicle, a **€1 500** deposit must be deposited by the crew members (who will be considered jointly liable towards the organization) to ensure compliance with the Specific Regulations of the event. The deposit can be made by check (for French participants only), bank transfer, credit card, or cash exclusively, before the registration deadline. AFRICA ECO RACE will only accept one payer per vehicle. The deposit will be refunded after the rally, except in cases of non-compliance with safety rules, at least one breach of obligations mentioned in the Specific Regulations, and the sporting ethics of the event. Failure to pay the deposit will result in the prohibition of participation in AFRICA ECO RACE.

## **ASSISTANCE**

Any competitor in the race who receives help or assistance from a person and/or vehicle not accredited by the organization will be disqualified from the race and will not have his deposit refunded.
